## **ENROLLMENT AGREEMENT**

## TRANSFERS ARE MADE IN CONJUNCTION WITH THE FEDERAL COURT ORDER AND ON THE FOLLOWING CONDITIONS:

- 1. Release (statement of no objection) from school zone Superintendent where student resides, if applicable.
- 2. Satisfactory attendance, academic performance and discipline at previous school. Attach copy of school transcript, (permanent record card), latest report card and conduct report. This is for new tuition students only.
- 3. Available space at the grade level and school site requested. (existing facility, services and staff will be a determining factor)
- 4. Transportation to and from the school is the responsibility of the parent/legal guardian.
- 5. Tuition students must apply for review and possible acceptance each year and subsequent school years.
- 6. The right to attend the district may be revoked for flagrant and/or persistent violations of the District's Code of Conduct and Attendance and other reasons outlined by the superintendent and/or her designee.
- 7. No student under suspension, expulsion or other disciplinary action by another school district will be considered for membership in the Talladega County School System.
- 8. Students will be accepted for enrollment at the beginning of the first and second semesters only. A complete application (attachments must be included for application to be considered complete) must be received by the school principal no later than fourteen (14) calendar days prior to the first student day of the semester in which the student is desiring to enroll. For the 2023-2024 school year, the last date complete applications will be accepted will be July 24 for the first semester, and December 15 for the second semester. Acceptance will be determined within 10 calendar days of the principal receiving a complete application.

## IF ALL THE ABOVE CONDITIONS ARE NOT MET, THIS APPLICATION WILL NOT BE CONSIDERED FOR APPROVAL.

Full tuition must be paid after an application has been accepted and approved and prior to the first student day of the semester in which the student is desiring to enroll. No tuition will be accepted on or after the first student day of the semester in which the student is desiring to enroll.

For the school year, tuition will be \$750.00 annually for one child; for any additional children from the same household, tuition will be \$450.00. Tuition is payable by certified check or money order and the total amount must be paid by the deadline before a student will be allowed to enroll or register for classes. In cases where there are two (2) or more children from the same household but will attend different schools, the tuition will be equally divided among the respective schools. Once the student is registered for classes, the tuition is non-refundable for any reason including, if it is necessary to dismiss the student for conduct or attitude detrimental to the school program.
