

  - 3. Successful interactions

#### WHAT DOES IT MEAN TO BE A TITLE I SCHOOL?

Being a Title I school means receiving federal funding (Title I funds) to **supplement** the school's existing programs. These funds are used for...

- Identifying students experiencing academic difficulties and providing timely assistance to help these students meet the State's challenging content standards.
- This money is intended to help struggling students to perform at proficient levels. Ex.) educational software
- Purchasing supplemental staff, programs, materials/supplies Ex.) technology, license fees, substitutes, Professional Development for staff, Interventionists, Title I Resource Teacher, Poster maker, math summer training, STEAM supplies



### WHAT DOES IT MEAN TO BE A "TITLE I SCHOOL"?

Being a Title I school means receiving federal funding (Title I dollars) to supplement the school's existing programs. These dollars are used for...

THE RIGHTS OF PARENTS IN A TITLE I SCHOOL

Being a Title I school also means parent and family involvement and knowing your rights under ESSA.

\*You as a parent have the right, by law, to be involved in the decision making process at Munford Middle School and Munford High School and at the Talladega County Board of Education.



### WHAT IS THE 1% SET-ASIDE AND HOW ARE PARENTS INVOLVED?

Any LEA with a Title I Allocation exceeding \$500,000 is required by law to set aside 1% of its Title I allocation for parent and family engagement.

• Of that 1%, 10% may be reserved at the LEA for system-wide initiatives related to parent and family engagement. The remaining 90% must be allocated to all Title I schools in the LEA. Therefore each Title I school receives its portion of the 90% to implement school-level parent and family engagement with clear expectations and objectives for meaningful involvement.

• MMS set aside for parent engagement was \$1,068.72. This is used to purchase pamphlets for Orientation Night at the beginning of the year and to hand out to new students/families throughout the year.

- MHS set aside for parent engagement was \$1,285.70. This will be used to purchase paper for parent involvement, newsletters, and student/teacher/parent compacts.
- You, as Title I parents, have the right to be involved in how this money is spent.



#### WHAT IS THE LEATITLE I PLAN?

- The LEA Title I Plan addresses how the LEA will use Title I funds throughout the school system. Topics include:
  - Student academic assessments
  - Additional assistance provided to struggling students
  - Coordination and integration of federal funds and programs
  - School programs including migrant, preschool, school choice, and supplemental educational services, as applicable.
  - Parent and Family Engagement Strategies, including the LEA Parent and Family Engagement Plan



You, as a Title I Parent, have a right to be involved in the development of the LEA Title I Plan (LEA Advisory Committee meets in April (Federal Programs Coordinator- Stephen Frank)



### WHAT IS THE LEA PARENT & FAMILY ENGAGEMENT PLAN?

This plan addresses how the LEA will implement the parent and family engagement requirements of the Every Student Succeeds Act. It includes...

- The LEA's expectations for parents
  - Talladega County sends home a Parent and Family Engagement Plan each year which outlines parent involvement expectations. This plan is updated each year with parent representatives from each school.
- How the LEA will involve parents and families in decision-making
  - Parent representatives have an opportunity to provide their input on engagement activities at the end of the year.
- The LEA will work to build the schools' and parents' capacity for strong parental involvement to improve student academic achievement

You, as Title I parents, have the right to be involved in the development of this plan The LEA Advisory Committee meets in April (parent surveys and parent representative).



#### WHAT IS A CIP?

The CIP is your school's Continuous Improvement Plan and includes:


- A Needs Assessment and Summary of Data
- Goals and Strategies to Address Academic Needs of Students
- Professional Development Needs
- Coordination of Resources/Comprehensive Budget
- The School's Parent and Family Engagement Plan
  - This plan is reviewed and updated throughout the year by our leadership team which consists of our parent representatives.
  - We look at student data from the iReady Assessment
  - Develop goals based on student strengths and weaknesses.
  - Based on test data, we are making gains in student achievement.
  - Areas of focus will still include reading and math proficiency.

You, as Title I parents, have the right to be involved in the development of this plan (Title I Advisory Committee).

# WHAT'S INCLUDED IN THE SCHOOL'S PFE PLAN?

- This plan addresses how the school will implement the parental involvement requirements of the Every Student Succeeds Act. Components include...
  - How parents can be involved in decision-making and activities
  - How parental involvement funds are being used
  - How information and training will be provided to parents
  - How the school will build capacity in parents and staff for strong parental involvement

You, as Title I parents, have the right to be involved in the development of your school's Parent and Family Engagement Plan (Parent Review Meeting, late April/early May).



# WHAT IS THE SCHOOL-PARENT COMPACT?

- The compact is a commitment from the school, the parent, and the student to share in the responsibility for improved academic achievement
- You, as Title I Parents, have the right to be involved in the development of the School-Parent Compact (Title I Advisory Committee and/or Parent Review Meeting)
- You should have received your child's compact and returned the signed copy to school.



# HOW DO I REQUEST THE QUALIFICATIONS OF MY CHILD'S TEACHERS?

- You, as Title I Parents, have the right to request the qualifications of your child's teachers
- How you are notified of this right and the process for making such request.


A letter goes home at the beginning of the school year. This is known as 'The Parent's Right to Know' found in the Rights and Privileges Booklet

# HOW IS THE EVALUATION OF THE LEA PFE PLAN CONDUCTED?

- Evaluation Requirements
  - Conduct annually
  - Conduct with Title I parents
  - Analyze Content and Effectiveness of the current plan
  - Identify Barriers to parental involvement
  - Data/Input may include...
    - Parent Survey (Required)
    - Focus Groups
    - Parent Advisory Committees
- Process and Timeline
- How the evaluation informs next year's plan
