

LHS Student Parking Permit Information

These regulations are in addition to information found in your Lincoln High School Student Handbook and the Talladega County Schools Student Rights and Responsibilities booklet. Permits are \$10.

Remember, driving to school and parking in the student parking lot is a **PRIVILEGE, not a RIGHT**. This PRIVILEGE may be revoked at any time for failure to abide by these rules.

All student drivers must...

-

- Park in their designated parking spot,
- Hang parking permit on rear view window,
- Possess a valid Alabama driver's license,
- Have insurance on each car you drive,
- Wear a seat belt and be sure all occupants of the vehicle do the same,
- Maintain a reasonable volume level on auto sound system (not heard outside the vehicle,)
- Enter and exit the parking lot at the correct location,
- Not exceed maximum speed of 5 MPH,
- Not drive recklessly,
- Remember that when you come onto the campus, YOU CANNOT LEAVE,
- Enter and exit campus using Patton Chappel Road entrance/exit,
- Not exit student parking lot in the afternoon until all busses have left,
- Cross the bus lanes at the crossing that leads from the football field to the field house.

A student vehicle parked anywhere on campus other than in one of the designated student parking lots is subject to being towed at owner's expense, and the student may be disciplined.

Lincoln High School is not responsible for damage to student vehicles that may occur through vandalism or carelessness by other drivers, or by any other reason. Lincoln High School is not responsible for property and valuables that may be stolen from vehicles. Students are encouraged to keep vehicles locked at all times.

**Remember, you are responsible for everything such as tobacco, weapons, or any other contraband that is in your vehicle. Having contraband in your vehicle is the same as having it on your person. **

A STUDENT VEHICLE IS SUBJECT TO BEING SEARCHED AT ANY TIME!**
