Mrs. Upchurch noted this presentation was in accordance with provisions of the School Fiscal Accountability Act, which requires her to present the audit report covering the period of October 1, 2018 through September 30, 2019. This audit was released to the public on April 17, 2020 on our website [www.examiners.alabama.gov](http://www.examiners.alabama.gov). The audit was conducted in accordance with generally accepted auditing standards and government auditing standards for the purpose of rendering an opinion on the financial statements and to determine whether the Board complied with applicable laws and regulations. An audit was also conducted of the Board's Federal Financial Assistance Program in accordance with the provisions of Title II US Code of Federal Regulations Part 200 Uniform Administrative Requirement. An unmodified opinion was issued on the Board's financial statements as of and for the period ending September 30, 2019. This means that the financial statements are presented fairly in accordance with generally accepted accounting principles. It was also noted no matters indicated that the Board had not complied in all material respects with applicable laws and

regulations. In addition, an unmodified opinion was issued on the Board's major federal financial assistance program which was the Child Nutrition Program cluster.
